

CITY OF SHAWNEE

ORDINANCE NO. 3269

AN ORDINANCE INCORPORATING BY REFERENCE THE INTERNATIONAL FUEL GAS CODE, 2018 EDITION, WITH OMISSIONS AND ADDITIONS, TO REGULATE THE ERECTION, CONSTRUCTION, ENLARGEMENT, ALTERATION, REPAIR, AND MAINTENANCE OF WATER HEATERS, FUEL GAS PIPING AND HEATING SYSTEMS IN THE CITY OF SHAWNEE, KANSAS.

NOW THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF SHAWNEE, KANSAS

PARAGRAPH 1. The Shawnee Municipal Code is hereby amended by repealing the previously existing Chapter 15.10 and providing in lieu thereof the following:

Chapter 15.10
INTERNATIONAL FUEL GAS CODE ADOPTED

Section 15.10.010 Incorporated by Reference.

There is hereby incorporated by reference the International Fuel Gas Code, 2018 Edition, prepared and published in book form by the International Code Council, Inc., 4051 West Flossmoor Road, Country Club Hills, Illinois 60478-5795, and hereby referenced as IFGC.

Section 15.10.020 Amendments and Additions.

The following sections of the IFGC, as adopted by Section 15.10.010, are amended as follows:

- A. Amend Section 101.1 Title, of the IFGC by replacing “[NAME OF JURISDICTION]” WITH “City of Shawnee, Kansas.”
- B. Amend by omitting Sections 103, 104, 105, 106, 108 and 109, of the IFGC, in their entirety, and amend by adding a new SECTION 103 ADMINISTRATIVE PROVISIONS, which reads:

**SECTION 103
ADMINISTRATIVE PROVISIONS**

The Administrative Provisions of the 2018 International Building Code, Chapter 1, in its entirety, and as modified by the Shawnee Municipal Code, along with Sections 101, 102 and 107 of the IFGC, shall govern all matters within the scope of the IFGC.

Section 15.10.30 Copies on File.

There shall be not less than one (1) copy of the code adopted by reference in Section 15.10.010 kept on file in the office of the City Clerk, to which shall be attached a copy of the incorporating ordinance, and which shall be marked or stamped, "Official Copy" as Incorporated by Ordinance No. 3269 with all sections or portions thereof intended to be omitted clearly marked to show any such deletion or change, and filed with the City Clerk and open to inspection and available to the public at all reasonable hours. The Fire Department, Municipal Judges and all administrative departments of the City charged with the enforcement of the incorporating ordinance shall be supplied, at the cost of the City, such number of official copies of such standard ordinance similarly marked, deleted and changed as may be deemed expedient.

PARAGRAPH 2. REPEALED - The previously existing Chapter 15.10 of the Shawnee Municipal Code in effect prior to the effective date of this Ordinance, is hereby repealed.

PARAGRAPH 3. SEVERABILITY - That if any section, subsection, sentence, clause or phrase of this ordinance is, for any reason, held to be invalid or unconstitutional, such decision shall not affect the validity or constitutionality of the remaining portions of this ordinance. The City of Shawnee, Kansas hereby declares that it would have passed this ordinance, and each section, subsection, clause or phrase hereof, irrespective of the fact that any one or more sections, subsections, sentences, clauses and phrases be declared unconstitutional.

PARAGRAPH 4. SAVINGS CLAUSE - Neither the adoption of this Ordinance nor the repeal or amendment of any section or portion thereof shall in any manner affect the prosecution for violation of this Ordinance or the International Fuel Gas Code adopted, which violations were committed prior to the effective date hereof, nor be construed as a waiver of any license, fee or penalty at said effective date and unpaid under such Ordinance or provision, nor be construed as affecting any of the provisions of such Ordinances or provisions relating to the collection of any such license, fee or penalty, or the penal provisions applicable to the violation thereof, nor to affect the validity of any bond or cash deposit in lieu thereof required to be posted, filed or deposited pursuant to any Ordinance, and all rights and obligations thereunder shall continue in full force and effect.


PARAGRAPH 5. EFFECTIVE DATE - This ordinance shall take effect and be in force on July 1st, 2019 after passage and publication as required by law. .






